- The development of metrology for the biotechnological area

# **OBJECTIVES OF THE CBMB**

- To serve as the national institution for the deposit of biological material for patent purposes
- To support the development of a national metrology system for the biotechnological area
- To provide a structure to support the Brazilian culture collections development and to guarantee its continuation




## **CBMB ACTIVITIES**

- Preservation of biological material deposited for patent purposes according to international requirements of safety, security and traceability
  - facilitate and stimulate patent applications in the Biotechnology field
- Furnishing of this material for research purposes according to internationally adopted rules
- Development of a national metrology program for biological material
- Maintenance of a backup of microorganisms and cell cultures of the Brazilian culture collections




#### **INTERMINISTERIAL ARTICULATION**

- One unit of INPI and one unit of Inmetro will be working in cooperation at the CBMB




## **CURRENT SITUATION AND PERSPECTIVES**

- Architectural project finalized
- Public tender for the construction in course
- Construction to be initiated in 2010
- Technical training for the staff: GLP, biosafety and biosecurity, shipping and other specific needs
- Studies for the development of operational procedures
- Parallel studies on national and international regulations and treaties
- Operation of the Center estimated to be initiated in the beginning of 2012
